Foreword

from Norman Goodwin CBE Chief Executive

Last year at this time I wrote about the potential exciting challenges of the coming year and about embracing the many changes and opportunities that lay ahead. None of us envisaged the changes to our world, our workplaces, to ourselves and our families as a result of Covid-19. As an agency - as a group of key workers - we have risen to the challenge and found new and innovative ways of working with and supporting our children and families. The resourcefulness and resilience of everyone has been truly remarkable, despite the personal difficulties these changes have imposed on us.

Undaunted, we placed 112 children for adoption, 83% of them for the Regional Adoption Agencies we work with across the North of England. We placed the 100th child through our Concurrent Planning Service in July 2019 and have now exceeded placing 100 children. Our Centre for Adoption Support and Therapy Service supported over 500 families and children and worked with 60 schools.

Sadly, there are still many children waiting for a forever family. Resources are still stretched within our national adoption system and the impact of Covid-19 and the resulting backlog of cases in the justice system will continue to affect children's lives. We stand ready to do all we can to make a difference for children and we hope that more families will come forward to meet the needs of those children who wait the longest. Our report shows that it can be a positive and rewarding journey, not half as daunting as some expected it to be and that our excellent staff can walk with you and support you all the way through the journey and beyond!

I always like to acknowledge the contribution of all our supporters, volunteers, panel members, Board of Trustees and staff without whom our achievements would not be possible.

I hope again that you will be inspired by what you read and will continue to support our work in whatever way you feel able.

A message

from our Chair of Board of Trustees, Carolyn Johnson

This has been a momentous record-breaking year for Adoption Matters in welcoming new adopters for 112 children. This is the highest number of children placed since our placement records were recorded in 1955. We have also approved more families than we have ever done welcoming 87 new families

This means new families and fresh starts for the most vulnerable children in our society. Our dedicated staff are inspired to work so hard, practically and imaginatively in ways to change families lives in the difficult days we have encountered this year. It is encouraging to find so many people who have responded to find out about adoption and a desire to open their homes and hearts to support those looked after children for the rest of their lives.

This year has seen the successful incorporation and development of the Durham office which has presented exciting opportunities for finding families in the North-East and more partnerships forged through the Regional Adoption Agencies in that area

Two of the former DFW trustees joined the Board along with Jamie Bennett, who also completed a sponsored bike ride for Adoption Matters from London to Paris on the hottest days of 2019 which was an amazing achievement. I am grateful to all Board members for their contributions and insight into the Board meetings and the unique experience they bring.

Since our Fundraising & Relationship Manager, Sarah Johnson was appointed, we have enjoyed several fundraising events which have helped to raise our profile on social media and the communities that we serve. The first ever Summer Lunch was held at The Grosvenor Hotel in Chester, a Tandem Skydive raised significant sponsorship and Will Week found several solicitors to participate.

The Ice Cream Farm in Cheshire nominated Adoption Matters as their Charity of the Year and we are extremely grateful to all their staff for embracing our charity with such enthusiasm, generating not only a significant financial contribution but helping to raise our profile to potential new families and supporters.

It is very disappointing therefore that most of the planned Fundraising events have been cancelled or postponed due to the pandemic since March but we have used imaginative opportunities to organise some virtual events.

The potential problems created by Covid-19 were well prepared for by Norman and our staff. Working remotely by using new technology had already been anticipated and our staff embraced this new technology with in house training and since the lockdown have been amazing in switching to working from home seamlessly and enthusiastically. The long-term impact we hope will improve and develop our way of working as a leading charity.

As a result no staff were furloughed and have been very impressive during the crisis in adapting to change, ensuring that the children we place and families we support have not suffered from the service we provide.

I am grateful for the help, support and advice provided by our Board and the tenacity and time dedicated to ensuring that Norman and the staff have the resources required to ensure that the service continues and flourishes despite the challenges raised by the pandemic.

I trust that you will be impressed by our achievements in a difficult, unpredictable year and will continue to support us in our vital work of finding loving families for vulnerable children to thrive in unprecedented times.

Our Achievements

Another record year for welcoming adopters and placing children!

We are again proud of the hard work and dedication of our staff, this year we placed 112 children with our families. 112 new starts, 112 forever families! This is the highest number of children placed since our placement records began in 1955. We have worked closely with our Regional Adoption Agency colleagues across the country to secure more children their forever home.





112 children were placed with our adoptive families



We welcomed and approved 87 new adopters

Our adopters included single people, people over the age of 50, LGBTQ adopters, single adopters and couples from a wide variety of backgrounds all across the country in the areas we work in; the North of England, Stoke, Staffordshire, Shropshire and parts of Wales.

Local families for local children

Adoption Matters covers the whole of the North of England, parts of Wales, Stoke, Staffordshire and Shropshire. We work very closely with our Regional Adoption Agency (RAA) and Local Authority (LA) colleagues across these areas in finding local families for local children.

We know that maintaining community, regional, cultural, education and family links is very important. It also helps to maintain the high quality and ongoing support we offer to our families when we are working with our RAA & LA colleagues with whom we have existing relationships across the areas we cover We are very proud that over 80% of the children we have placed in 2019-20, are with local families.

There will always be cases when a family who can best meet the child's needs is not local to the placing authority and so we also work with RAAs/LAs across the whole of the UK

It's not about finding a child for a family, but very much the right family for the child - children are at the centre of everything we do.



Our Concurrent Planning Service, run in partnership with Caritas Care, refined its service area to concentrate on the North West of England. In July 2019, the service marked the 100th placement at a celebratory event attended by partners at Regional Adoption Agencies Adoption Now, AIM, Together for Adoption and Adoption Counts along with several families.

Kate Knowles, Concurrent Planning Practice Manager said, "I'm so proud to have been part of this service since it started in 2014. Our carers never cease to amaze me with their courage and commitment to the children placed with them. These selfless acts, putting the best interest of the children first, really articulate what this service is all about and without them, 100 children would not have had this positive start to their lives."

Karen Barrick, Head of Service, Adoption Now said, "We have worked closely with the Concurrent Planning team over the past 5 years and what we know is that concurrency works, it provides the best outcome for our children. My special thanks go to the carers, who take on this role with uncertainty but also knowing that whatever the outcome, they have been instrumental in giving children a positive beginning."

Our Centre for Adoption Support

In October 2019, the Centre for Adoption Support became an Adoption Matters only service, offering a comprehensive range of adoption support services to its own adoptive families and undertaking commissioned work.

The Centre has continued to grow into a much valued and respected professional service supporting our families and providing commissioned adoption support services to Local Authorities, Regional Adoption Agencies and educational professionals.

In early 2020, we launched a new website for the service which enables adopters and professionals to book workshop places online.





Music Matters

This workshop, funded through a grant from Youth Music Network and support from The River Reeves Foundation, aims to support children and young people develop their musical skills. They have the opportunity to learn to play instruments, sing, DJ and write songs to see what it is like to be a musician. One of the best parts of the session is the children can make music together and they have the opportunity to meet other adopted children and build friendships.



Asian adopters support group

The group was set up to allow people who had similar cultural identities to come together and discuss their journeys into adoption within a safe, comfortable environment of like minded people.

Within the group, people benefitted from hearing a direct experience on a child's adoption journey as an adopted adult attended the group. The attendees were able to discuss a wide range of issues from how trauma impacts on children's brains to what therapeutic parenting entailed and the challenges this came with.




Their challenge has raised over £3,000 for Adoption Matters.

Five of the thrill-seekers included staff members, Tommy, Deanna, Ollie, Amy and James from the Ice Cream Farm in Tattenhall, Cheshire. Their efforts are just one in a series of fundraising events by The Ice Cream Farm, as the Charity of the Year. Alongside the Tandem Skydive The Ice Cream Farm supported the event by displaying donation boxes across their site and raising awareness about adoption and the shortage of adoptive parents.

Adopters Rachel & Paul share their story:

My husband, Paul and I adopted a sibling group of three children, Sarah, Ryan and Holly, who were just 3 years old and 19 months (twins).

We had come to adoption through not being able to have birth children and had always wanted a large family. It therefore made sense for us to adopt a sibling group. Seeing the family likeness between them then, and as they have grown up, has been a joy. Sibling groups are so often split up because finding families for them is hard and this would have been the case for our three children had we not adopted them.

Our friends laughed at us when we said we were planning to adopt three children at once and we soon found out why when they arrived! Becoming parents overnight was a shock; it was very intense and fairly overwhelming for the first few months.

We had a lot of support through Adoption Matters, both at the time and since, through the Centre For Adoption Support. Once the children were in school and life had settled down I trained as a social worker, working first in child protection before becoming an adoption social worker.

I have worked for Adoption Matters since 2014 and I have found it so rewarding being able to use my personal experience as an adopter when training and assessing adopters now.

As a family we have always been members of a local church and through the church we have been massively supported. Adoption Matters works in partnership with Home for Good, a Christian charity, and through them and the wider church we have been able to help and support many families considering adoption and those that are sometimes struggling with the reality of parenting traumatised

Sarah, Ryan and Holly chose to do a tandem skydive in 2019, as they all love a challenge, particularly where there is an adrenalin rush! They have always known about being adopted we have a family birthday every year to celebrate the day they moved in and we became a family. They also know all about their birth history and background and why they were adopted. This has given them the desire to want to do something for Adoption Matters who brought us together".

Sarah, Ryan and Holly commented:

"We were really excited to do the skydive jump as a way of giving back to Adoption Matters for all the work they have done in getting us to where we are in our lives today, and for the work that they will continue to do for the years to come for other families across the country. We were delighted that along with the other five team members who took part, that we managed to raise over £3,000!".









Supporter cycles 340 miles from London to Paris for Adoption Matters

When Jamie Bennett saw the Eiffel Tower he knew he had finally reached his goal, cycling from London to Paris over 4 days during one of Britain's hottest heatwaves from 24-28 July 2019, whilst raising an amazing £2,365.00 (+£472.73 Gift Aid) for Adoption Matters.

Jamie was inspired to help Adoption Matters as he was placed for adoption through the charity. Jamie comments:

"Many years ago Adoption Matters placed me with the lovely family who made me who I am; and many years later they reconnected me with the family who completed me. I owe this charity the world so it was a pleasure to support this very worthy cause".

The epic challenge was even more treacherous due to the heat and during Leg 2 in France the organisers took the decision to finish 30 miles early and collect all the participants by coach for fear of heat exhaustion! Jamie battled on finishing on time at the Eiffel Tower in Paris.

Adoption Matters Chief Executive Norman Goodwin, CBE commented: "We all followed Jamie's trip on social media and we were so proud he cycled this huge distance despite the blistering heat! It is always rewarding for us when adopted adults support our charity and we are also delighted that Jamie is now a member of our Board of Trustees, meaning his experience and knowledge as an adopted adult can help influence our policies and practice".



Supporter chooses Adoption Matters 54 years after adopting her two children

Supporters Ruth and Steve Talbot, from Ellesmere Port, Cheshire raised the amazing amount of £6,830 with the Lions Clubs District 105BS.

Ruth Talbot, adopted her two children through Adoption Matters (then known as Chester Diocesan Adoption Agency or CDAS) over 54 years ago, and chose us as her charity to support for the Lions Club District Governor Partner's Appeal 2018/19 during Steve's term of office. The Lions Club has over 1.4 million members worldwide and is the largest service organization in the world. They are dedicated to helping those in need.

Ruth explains why the charity is close to her:

"I have two children who I adopted to give them a secure, loving and stable upbringing. Following my marriage, I applied to adopt a child, however, we ended up adopting two! Julie was adopted in 1965 when she was 5 weeks old and Simon in 1967 at just 6 weeks old. In 1968, I was then blessed with my birth son Mark.

Obviously, all my children had different genes and characters but they grew very close as siblings and remain so to this day. I believe every child deserves a safe, secure and loving environment. Julie and Simon have become fine adults and have grown up children of their own which gives me a warm feeling of satisfaction that I was able to give them a forever home and feel honoured and privileged to have done so

Mark my birth son also has an adopted daughter who has two children. Isn't that amazing?"
