Gift Aid

What is Gift Aid - Gift Aid allows charities to reclaim the tax paid on the donation at no cost to the individual.

Why should I Gift Aid my donation? - By completing the Gift Aid declaration form below, Adoption Matters can increase your donation by 25% at no extra cost to you.

Who can Gift Aid? - To qualify for Gift Aid, you must pay at least the same income tax or capital gains tax in one year (6 April one year to 5 April the next) as we claim on your gift (currently 25p for every £1 you donate). As you can imagine, this makes a huge difference to our donations.

Boost your donation by 25p of Gift Aid for every £1 you donate. Gift Aid is reclaimed by the charity from the tax you pay for the current tax year. Your address is needed to identify you as a current UK taxpayer.
