Foreword from Norman Goodwin CBE Chief Executive

For most of 2020 and continuing into 2021, Adoption Matters has continued to work under the constraints imposed upon us and subject to the continuing implications of Covid-19. Much of what we implemented during last year has been built upon and new and innovative ways have continued to be found by our inventive staff to best serve those whom we seek to work with in delivering an outstanding adoption service.

Despite many difficulties, we placed 91 children with our families and approved 81 new adopters. 23% of these children were part of a sibling group of 2 or more. Finding families for brothers and sisters to grow up together is something we are passionate about. 85% of the children placed were placed with the Regional Adoption Agencies we work closely with offering them local placements for their children and helping them meet their capacity to find families in a timely way. The partnership encourages early notification about children needing to be placed and allows us to recruit the types of adopters to meet the needs of the children waiting. We are also able to identify those children who might wait the longest and look at how we can specifically recruit families for those children.

This year has also seen greater working together with the leaders of other Voluntary Agencies (via the CVAA) and the Regional Adoption Agencies to deliver a 21st Century Adoption Service. I always like to acknowledge the contribution of all our supporters, volunteers, panel members, Board of Trustees and staff, without whom, our achievements would not be possible.

I hope again that you will be inspired by what you read and will continue to support our work in whatever way you feel able.

A message from our Chair of Board of Trustees, Carolyn Johnson

This has been an extremely challenging year for Adoption Matters and particularly for our staff and families as they faced the Covid-19 global pandemic, having to adapt their working practices and make acute, swift changes to their lifestyles.

Gratifyingly, the charity was well prepared and had already implemented innovative IT structures to enable communication to continue effectively and for staff to work from home with suitable equipment and the latest technology. As a result of its success, many of the innovations that have enhanced the service we provide to families will be retained, saving travelling hours and allowing conversations and meetings to take place without organisational delays. We will welcome the resumption of face to face meetings but we have certainly benefitted this year from the foresight of our CEO and managers in enhancing our IT systems well ahead of the pandemic.

This report outlines the significant achievements and exciting events that have happened this year, despite the difficulties caused by the pandemic. I applaud and am impressed by the ingenuity and resourcefulness demonstrated by our staff and volunteers.

Our influence and research on adoption practice is acknowledged nationally by the launch event on "Understanding Early Permanence" which was hosted by our CEO and attracted over 170 delegates with the research being put into training and practice.

Adoption Matters' vast experience has also been used to inform the Children's Minister about the deficits in adoption practice nationally by participating with CVAA in discussion and also by being involved in the All Party Parliamentary Group for Adoption and Permanence.

This year Norman Goodwin has announced that he is to retire at the end of 2021 after 36 years working for Adoption Matters; 30 years of which he has been CEO! His national profile, diligence, dedication, huge popularity and recognition for his personal support for staff, adopters and network of adoption charities, voluntary agencies and Government means the Board has been faced with a very demanding task to appoint his successor. A Succession Planning Group of experienced trustees has been formulating a professional, rigorous procedure for 2 years in order to ensure his successful legacy is preserved.

I wish to personally express my gratitude to our Board of Trustees, Norman and all the staff, panel members, volunteers and supporters for their loyalty and commitment throughout this turbulent year, to Adoption Matters, the vulnerable children and families that lie at the heart of everything we do.







Despite one of the most challenging years, we continued with our work with children and families despite everything we faced during the Covid-19 global pandemic, to ensure that children did not experience more delay in finding their permanent family.

We are again proud of the hard work and dedication of our staff, this year we placed 91 children with our families and we welcomed and approved 81 new adopters. Our adopters included single people, people over the age of 50, LGBTQ+ adopters and individuals and couples from a wide variety of backgrounds all across the North of England, Stoke, Shropshire and parts of Wales.







Local families for local children

Adoption Matters covers the whole of the North of England, parts of Wales, Stoke, Staffordshire and Shropshire. We work very closely with our Regional Adoption Agency (RAA) and Local Authority (LA) colleagues across these areas in finding **local families for local children**.

We know that maintaining community, regional, cultural, education and family links is very important. It also aids to maintaining the high quality and ongoing support we offer to our families when we are working with our RAA & LA colleagues with whom we have existing relationships across the areas we cover. We are very proud that for the second year running, 85% of the children we have placed in 2020-21, are with local families.

There will always be cases when a family who can best meet the child's needs is not local to the placing authority and so we also work with RAAs/LAs across the whole of the UK.

It's not about finding a child for a family, but very much the right family for the child - children are at the centre of everything we do.

In March 2021, we hosted a launch event for research which was commissioned and funded by Adoption Matters along with Caritas Care and Barnardo's in order to further understanding of early permanence approaches and how they can be better developed. "Understanding Early Permanence: A Small scale research study" by Rebecca Brown and Claire Mason (University of Lancaster).

Over 170 delegates joined the event hosted by our CEO Norman Goodwin, CBE on Zoom joining a number of presenters alongside the lead researchers Rebecca Brown and Claire Mason including: Dr. John Simmonds, OBE Director of Policy Research and Development at CoramBAAF, Research and Development Karen Barrick, Head of Service Adoption NoW, Michelle Rawlings, Service Delivery Manager One Adoption West Yorkshire, Judith Sargent, Adoption and Fostering Operations Manager Yorkshire, Barnardo's and Susan Swarbrick, CEO at partnership agency Caritas Care.

Following the event, Julie Hogan and Kate Knowles from the Concurrent Planning Service delivered practice based training to the CVAA in relation to concurrent planning and joint training to CVAA with Rebecca Brown and Claire Mason in order to put the research into practice.

Julie Hogan, Kate Knowles and two concurrent planning carers were also invited to speak to the All-Party Parliamentary Group for Adoption and Permanence (APPGAP) on early permanence.





Our Centre for Adoption Support & Therapy Service

The demand for our support increased threefold during the pandemic and we worked hard to ensure that our families and children continued receive the on-going support they needed.

We realised that there was a need for a different kind of support package for the families impacted by current events. Families needed access to professionals who could help all members of the family to develop effective self-regulation skills, either to get through a difficult period, such as the first months after the child moved into their home, or a period of acute family crisis later on. We quickly developed and adapted our offer to meet this need during the pandemic.

During school shut downs and home schooling, we offered tailored videos and advice to help children and families cope and we also produced a "Transitioning your child back to school with PACE" video for both families and schools.

All of our Centre for Adoption Support staff continued to work tirelessly throughout the pandemic offering support with telephone and online video consultations, webinars and when needed and safe to do so, face to face therapeutic consultations

Therapy Service

Our therapy service delivered 239 contracts offering a range of therapeutic interventions for children and families. In addition to this they also delivered 74 Covid support packages to families. The service also saw an unprecedented rise in the need for therapy during Covid-19 and the team of 25 therapists continued to work, often face to face, with high crisis cases, throughout pandemic and lockdown periods.

Our therapists worked hard on developing therapeutic services that could be delivered online and feedback from families is that the online support has been helpful and supportive. The service also set up mindfulness groups for adopters which has helped maintain their psychological well-being and emotional resilience and they also plan to offer Nurturing Attachments groups in the near future.


